APPLICATION

On July 16, 2015, Ursa Operating Company LLC, Operator No. 10447, (“Ursa” or “Applicant”) filed a verified application pursuant to §34-60-116, C.R.S., for an order to:

1) Pool all interests in the approximate 320-acre drilling and spacing unit established for the Application Lands, for the development and operation of the Williams Fork and Iles Formations, effective as of the earlier of the date of this Application, or the date that the costs specified in §34-60-116(7)(b), C.R.S. are first incurred for the drilling of the initial well within the Application Lands; and

2) Subject any nonconsenting interests to the cost recovery provisions of §34-60-116(7), C.R.S., for the drilling of the Yater 41D-18-07-95 Well (API No. 05-045-22828), the Yater 42A-18-07-95 Well (API No. 05-045-22824), the Yater 42B-18-07-95 Well (API No. 05-045-22827), the Yater 42C-18-07-95 Well (API No. 05-045-22826), and the Yater 42D-18-07-95 Well (API No. 05-045-22757).

- On April 28, 2014, the Commission entered Order No. 440-71 which, among other things, established an approximate 320-acre laydown drilling and spacing unit for the Application Lands, and approved the equivalent of one well per 10-acre bottomhole well density within the unit, for the production of gas and associated hydrocarbons from the Williams Fork and Iles Formations.

Pursuant to Rule 511., if the matter is uncontested, it may be approved without a hearing.
