On August 27, 2015, Cub Creek Energy, LLC (“Cub Creek” or “Applicant”), Operator #10542, filed a verified amended application pursuant to §34-60-116, C.R.S., for an order to:

- 1) Pool all interests an approximate 320-acre drilling and spacing unit established for the Application Lands, for development and operation of the Niobrara and Codell Formations; and
- 2) Subject any nonconsenting interests to the cost recovery provisions of §34-60-116(7), C.R.S., effective as of the earlier of the date of the Application, or the date that any of the costs specified in §34-60-116(7)(b), C.R.S., are first incurred for the drilling of any authorized horizontal well for the Niobrara and Codell Formations; and

- On April 27, 1998, the Commission adopted Rule 318A, the Greater Wattenberg Area Special Well Location, Spacing and Unit Designation Rule.
- On February 19, 1992, the Commission issued Order No. 407-87 (amended August 20, 1993) which, among other things, established 80-acre drilling and spacing units for the production of oil, gas and associated hydrocarbons from the Codell and Niobrara Formations, with the permitted well locations in accordance with the provisions of Order No. 407-1. The Application Lands are subject to this Order for the Codell and Niobrara Formations.
- On September 14, 2015, the Commission entered Order No. 407-1416 establishing an approximate 320-acre drilling and spacing unit for the Application Lands, and approving the drilling of nine horizontal wells within the proposed unit, for the production of oil, gas and associated hydrocarbons from the Niobrara and Codell Formations.

NOTICE IS HEREBY GIVEN, pursuant to: 1) the general jurisdiction granted to the Oil and Gas Conservation Commission of the State of Colorado under §34-60-105 C.R.S.; 2) specific powers granted pursuant to §34-60-106 C.R.S.; 3) the State Administrative Procedures Act at §24-4-105 C.R.S.; and 4) the Commission's Series 500 Rules at 2 CCR 404-1, that the Commission has scheduled the above-entitled matter for hearing on:

Anyone who files a protest or intervention must be able to participate in a prehearing conference during the week of October 12, 2015. Pursuant to Rule 511., if the matter is uncontested, it may be approved without a hearing.
