1) Pool all interests in seven approximate 320-acre horizontal wellbore spacing units, established for the Application Lands, for the development and operation of the Niobrara and Codell Formations; and

2) Subject any nonconsenting interests to the cost recovery provisions of §34-60-116(7), C.R.S., effective as of the earlier of the date of the Application, or the date that any of the costs specified in §34-60-116(7)(b), C.R.S., were first incurred for the drilling of the Newnam 2C-32H-C264 Well (API No. 05-123-39774) (WSU #1), the Newnam 2E-32H-C264 Well (API No. 05-123-39776) (WSU #2), the Newnam 2F-32H-C264 Well (API No. 05-123-39778) (WSU #3), the Newnam 2G-32H-C264 Well (API No. 05-123-39781) (WSU #4), the Newnam 2H-32H-C264 Well (API No. 05-123-39772) (WSU #5), the Newnam 2I-32H-C264 Well (API No. 05-123-39780) (WSU #6), and the Newnam 2J-32H-C264 Well (API No. 05-123-39779) (WSU #7).
