On August 27, 2015, Kerr-McGee Oil & Gas Onshore LP, Operator No. 47120 ("Kerr-McGee" or "Applicant") filed a verified application pursuant to §34-60-116, C.R.S., for an order to:

- 1) Pool all interests in four approximate 320-acre to 640-acre horizontal wellbore spacing units established for the Application Lands, for the development and operation of the Codell and Niobrara Formations; and
- 2) Subject any nonconsenting interests to the cost recovery provisions of §34-60-116(7), C.R.S., effective as of the earlier of the date of the Application, or the date that any of the costs specified in §34-60-116(7)(b), C.R.S., were first incurred for the drilling of the Meguire 4N-16HZ Well (API No. 05-123-41937) (WSU #1), the Meguire 29C-16HZ Well (API No. 05-123-41938) (WSU #2), the Meguire 29N-16HZ Well (API No. 05-123-41975) (WSU #3), and the Meguire 3N-16HZ Well (API No. 05-123-41978).
