#### **APPLICATION**

On August 27, 2015, Noble Energy, Inc. (Operator No. 100322) ("Noble" or "Applicant"), filed a verified application pursuant to §34-60-116, C.R.S. for an order to:

- 1) Pool all interests in an approximate 640-acre drilling and spacing unit established for the Application Lands, for the development and operation of the Codell and Niobrara Formations; and
- 2) Subject any non-consenting interests to the cost recovery provisions of §34-60-116(7), C.R.S., effective as of the earlier of the date of the Application, or the date that any of the costs specified in §34-60-116(7)(b), C.R.S. were first incurred for the drilling of the Brecken LD28-727 Well (API No. 05-123-41567), the Brecken LD28-734 Well (API No. 05-123-41565), the Brecken LD28-740 Well (API No. 05-123-41568), the Brecken LD28-747 Well (05-123-41566), the Greyson LD28-753 Well (API No. 05-123-41586), the Greyson LD28-760 Well (API No. 05-123-41587), the Greyson LD28-767 Well (API No. 05-123-41588), or the Greyson LD28-780 Well (API No. 05-123-41584).

#### PRIOR RULES AND ORDERS

- On February 22, 2011, the Commission entered Order No. 535-3 which established 160 approximate 640-acre drilling and spacing units for certain lands in Townships 8, 9 and 10 North, Ranges 58 through 61 West, 6<sup>th</sup> P.M., and approve one horizontal well in each unit, for the production of oil, gas and associated hydrocarbons from the Niobrara Formation.
- On December 15, 2014, the Commission entered Order No. 535-615 which, among other things, approves the request for an order to: 1) establish an approximate 640-acre drilling and spacing unit for the Application Lands, for the production of oil, gas and associated hydrocarbons from the Codell Formation; 2) approve up to 10 horizontal wells within the unit, for the production of oil, gas and associated hydrocarbons from the Codell Formation; 3) approve an additional nine wells, for a total of up to 10 horizontal

wells, within an approximate 640-acre drilling and spacing unit established by Order No. 535-3 for the Application Lands, for the production of oil, gas and associated hydrocarbons from the Niobrara Formation.

Pursuant to Rule 511, if the matter is uncontested, it may be approved without a hearing, based on review of the merits of the verified application and supporting exhibits.
