APPLICATION

On July 31, 2015, Winston Dines ("Dines" or "Payee") filed an Application pursuant to §34-60-118.5, C.R.S., for an order to award payment of proceeds, interest, and an award of costs and attorney's fees due to Payee for production attributable to the royalty due from Linn Operating Inc., a wholly owned subsidiary of Linn Energy, LLC (Operator No. 10516) ("Linn" or "Payor") for the abovementioned Wells located in Garfield County, Colorado, from March 2007 through present.

APPLICABLE STATUTE

On July 1, 1990, through Section 34-60-118.5, C.R.S., the Colorado Oil and Gas Conservation Commission with exclusive jurisdiction concerning the payment of proceeds derived from the sale of oil, gas or associated products from a well in Colorado including the following:

- (a) The date on which payment of proceeds is due a payee under section (2) of the section;
- (b) The existence or nonexistence of an occurrence pursuant to subsection (3) of this section which would justifiably cause a delay in payment; and
- (c) The amount of the proceeds plus interest, if any due a payee or payor.

NOTICE IS HEREBY GIVEN, pursuant to: 1) the general jurisdiction granted to the Oil and Gas Conservation Commission of the State of Colorado under §34-60-105, C.R.S.; 2) specific powers granted pursuant to §34-60-106, C.R.S.; 3) the State Administrative Procedures Act at §24-4-105, C.R.S.; and 4) the Commission's Series 500 Rules at 2 CCR 404-1, that the Commission has scheduled the above-entitled matter for hearing on:

One electronic (cogcc.hearings\_unit@state.co.us), one original and two copies shall be filed with the Commission. **Anyone who files a protest or intervention must be able to participate in a prehearing conference during the week of October 12, 2015.** Pursuant to Rule 511., if the matter is uncontested, it may be approved without a hearing.
