TO ALL INTERESTED PARTIES AND TO WHOM IT MAY CONCERN:

APPLICATION

On October 8, 2015, Bill Barrett Corporation, Operator No. 10071 ("BBC" or "Applicant") filed a verified application pursuant to §34-60-116, C.R.S., for an order to:

- 1) Vacate the approximate 640-acre drilling and spacing unit established by Order Nos. 407-560 for Section 30, Township 4 North, Range 62 West, 6th P.M., for the production of oil, gas and associated hydrocarbons from the Niobrara Formation;
- 2) Establish an approximate 1,280-acre drilling and spacing unit for Sections 29 and 30, Township 4 North, Range 62 West, 6th P.M., and approve up to sixteen horizontal wells within the unit, for the production of oil, gas and associated hydrocarbons from the Niobrara Formation;
- 3) Establish an approximate 1,280-acre drilling and spacing unit for Sections 29 and 30, Township 4 North, Range 62 West, 6th P.M., and approve up to four horizontal wells within the unit, for the production of oil, gas and associated hydrocarbons from the Codell Formation;
- 4) Require the productive intervals of the wellbore to be no closer than 460 feet from unit boundaries, and no closer than 150 feet from the productive interval of any other wellbore located in the unit, unless an exception is granted by the Director.
- 5) Applicant states that the proposed wells shall be located on no more than five multi-well pads subject to Rule 318A, unless an exception is granted by the Director.

- On April 27, 1998, the Commission adopted Rule 318A, the Greater Wattenberg Area Special Well Location, Spacing and Unit Designation Rule.

- On June 27, 2011 (corrected February 14, 2012), the Commission entered Order No. 407-560 which, among other things, established 640-acre drilling and spacing units for certain lands, including Section 30, Township 4 North, Range 62 West, 6th P.M. of the Application Lands, and approved one horizontal well for each unit, for the production of oil, gas and associated hydrocarbons from the Niobrara Formation.


