APPLICATION

On October 8, 2015, Bill Barrett Corporation, Operator No. 10071 ("BBC" or "Applicant") filed a verified application pursuant to §34-60-116, C.R.S., for an order to:

- 1) Vacate the approximate 640-acre drilling and spacing unit established by Order No. 407-497 for Section 27, Township 4 North, Range 62 West, 6th P.M., for the production of oil, gas and associated hydrocarbons from the Niobrara and Codell Formations;
- 2) Establish an approximate 1,280-acre drilling and spacing unit for Sections 27 and 28, Township 4 North, Range 62 West, 6th P.M., and approve up to sixteen horizontal wells within the unit, for the production of oil, gas and associated hydrocarbons from the Niobrara Formation;
- 3) Establish an approximate 1,280-acre drilling and spacing unit for Sections 27 and 28, Township 4 North, Range 62 West, 6th P.M., and approving up to four horizontal wells within the unit, for the production of oil, gas and associated hydrocarbons from the Codell Formation;
- 4) Require the productive intervals of the wellbore to be no closer than 460 feet from unit boundaries, and no closer than 150 feet from the productive interval of any other wellbore located in the unit, unless an exception is granted by the Director.
- 5) Applicant states that the proposed wells shall be located on no more than five multi-well pads subject to Rule 318A, unless an exception is granted by the Director.

- On April 27, 1998, the Commission adopted Rule 318A, the Greater Wattenberg Area Special Well Location, Spacing and Unit Designation Rule.

- On June 17, 2013, the Commission entered Order No. 407-797 which, among other things, established 640-acre drilling and spacing units including Section 27, Township 4 North, Range 62 West, 6th P.M., and approved one horizontal well for each unit, for the production of oil, gas and associated hydrocarbons from the Niobrara and Codell Formations.
