APPLICATION

On October 8, 2015, Extraction Oil & Gas LLC (Operator No. 10459) ("Extraction" or "Applicant") filed a verified application pursuant to §34-60-116, C.R.S., for an order to:

1) Pool all interests in two approximate 240-acre horizontal wellbore spacing units, established for the Application Lands, for the development and operation of the J-Sand and Codell Formations; and

2) Subject any nonconsenting interests to the cost recovery provisions of §34-60-116(7), C.R.S., effective as of the earlier of the date of the Application, or the date that any of the costs specified in §34-60-116(7)(b), C.R.S., were first incurred for the drilling of the Fairview #2 Well (API No. 05-123-41666) – J-Sand Formation – WSU #1, and the Fairview #11 Well (API No. 05-123-41524) – Codell Formation – WSU #2.
