APPLICATION

On November 23, 2015, PDC Energy, Inc. (Operator No. 69175) ("PDC" or "Applicant"), filed a verified application pursuant to §34-60-116, C.R.S. for an order to:

1) Subject additional parties to Order No. 407-934, which pools all interests in an approximate 400-acre designated horizontal wellbore spacing unit, for the development and operation of the Codell Formation.

2) Subject any non-consenting interests to the cost recovery provisions of §34-60-116(7), C.R.S., effective as of the earlier of the date of the Application, or the date that any of the costs specified in §34-60-116(7)(b), C.R.S. were first incurred for the drilling of the Simonsen 11-421 Well (API No. 05-123-35976).

- On April 27, 1998, the Commission adopted Rule 318A, the Greater Wattenberg Area Special Well Location, Spacing and Unit Designation Rule.
- On February 19, 1992 (amended August 20, 1993), the Commission entered Order No. 407-87 which, among other things, established 80-acre drilling and spacing units, for the production of oil, gas and associated hydrocarbons from the Niobrara Formation underlying certain lands, including the Application Lands, with the permitted well locations in accordance with the provisions of Order No. 407-1.
- On January 27, 2014, the Commission entered Order No. 407-934, which among other things, pooled all interests in an approximate 400-acre designated wellbore spacing unit for the Well, for the development of the Codell Formation. Applicant requests that additional parties be subject to Order No. 407-934.
