APPLICATION

On November 23, 2015, Great Western Operating Company, LLC (Operator No. 10110) ("Great Western" or "Applicant"), filed a verified application pursuant to §34-60-116, C.R.S. for an order to:

1) Modify Order No. 407-1488, to pool all interests in an approximate 640-acre designated horizontal wellbore spacing unit, for the development and operation of the Codell Formation; and

2) Subject any non-consenting interests to the cost recovery provisions of §34-60-116(7), C.R.S., effective as of the earlier of the date of the Application, or the date that any of the costs specified in §34-60-116(7)(b), C.R.S. were first incurred for the drilling of the Burr FD 23-382HC Well (API No. 05-123-40877) (Formerly the Burr FD 23-382HN).

- On April 27, 1998, the Commission adopted Rule 318A, the Greater Wattenberg Area Special Well Location, Spacing and Unit Designation Rule.
- On February 19, 1992 (amended August 20, 1993), the Commission entered Order No. 407-87 which, among other things, established 80-acre drilling and spacing units for the production of oil, gas and associated hydrocarbons from the Codell-Niobrara Formations, the Codell Formation, and the Niobrara Formation underlying certain lands, including the Application Lands, with the permitted well locations in accordance with the provisions of Order No. 407-1.
- On October 26, 2015, the Commission entered Order No. 407-1488, which among other things, approves the request for an order to pool all interests in an approximate 640-acre

designated horizontal wellbore spacing unit for the Application Lands, for the development of the Niobrara Formation. Applicant requests Order No. 407-1488 be modified to pool the Burr FD 23-382HC Well (Formerly the Burr FD 23-382HN Well) to the Codell Formation.
