On November 25, 2015, Extraction Oil & Gas LLC (Operator No. 10459) ("Extraction" or "Applicant") filed a verified application pursuant to §34-60-116, C.R.S., for an order to:

1) Pool all interests in five approximate 640-acre horizontal wellbore spacing units, established for the Application Lands, for the development and operation of the Niobrara Formation; and

2) Subject any nonconsenting interests to the cost recovery provisions of §34-60-116(7), C.R.S., effective as of the earlier of the date of the Application, or the date that any of the costs specified in §34-60-116(7)(b), C.R.S., were first incurred for the drilling of the Diamond Valley East #3 Well (API No. 05-123-38500) (WSU #1), the Diamond Valley East #5 Well (API No. 05-123-38498) (WSU #2), the Diamond Valley East #6 Well (API No. 05-123-38568) (WSU #3), the Diamond Valley East #8 Well (API No. 05-123-39183) (WSU #4), and the Diamond Valley East #9 Well (API No. 05-123-38760) (WSU #5).
