On November 25, 2015, Grizzly Operating LLC (Operator No. 10590) ("Grizzly" or "Applicant") filed a verified application pursuant to §34-60-116 C.R.S., for an order to:

- 1) Pool all interests in an approximate 160-acre designated wellbore spacing unit, established for the Application Lands, for the development and operation of the Codell and Niobrara Formations; and
- 2) Subject any nonconsenting interests to the cost recovery provisions of §34-60-116(7), C.R.S., effective as of the earlier of the date of the Application, or the date that any of the costs specified in §34-60-116(7)(b), C.R.S., were first incurred for the drilling of the Goza #2-Ae Well (API #05-123-38401).
