On December 3, 2015, Anadarko E&P Onshore LLC, Operator No. 2800 ("Anadarko" or "Applicant") filed a verified application pursuant to §34-60-116, C.R.S., for an order to:

1) Subject any nonconsenting interests to the cost recovery provisions of §34-60-116(7), C.R.S., effective as of the earlier of the date of the Application, or the date that any of the costs specified in §34-60-116(7)(b), C.R.S., were first incurred for the drilling of the Resolution Fed 12-65-26-23-6CH (API No. 05-123-41705).

- On October 27, 2014, the Commission entered Order No. 535-569 which established an approximate 1,360-acre drilling and spacing unit for the Application Lands for the production of oil, gas and associated hydrocarbons from the Codell Formation; and approved one horizontal well within the unit.
- On December 8, 2015, the Commission entered Order No. 535-712 which pooled all interests within an approximate 1,360-acre drilling and spacing unit established for the Application Lands, for the development and operation of the Codell Formation.
