NOTICE OF HEARING

APPLICATION

On January 5, 2016, GRMR Oil & Gas, LLC (Operator No. 10524) ("GRMR" or "Applicant") filed a verified application pursuant to Section 34-60-116, C.R.S., for an order to:

- 1) Establish one approximate 812.97-acre drilling and spacing unit for production of oil, gas, and associated hydrocarbons from the Niobrara Formation;
- 2) Approve the following five wells currently drilled in the proposed unit:
 - a. Deal Gulch #1-16 (API No. 05-081-07721)
 - b. Deal Gulch #2-16 (API No. 05-081-07753)
 - c. Deal Gulch #4-16 (API No. 05-081-07768)
 - d. Deal Gulch #6-16 (API No. 05-081-07766)
 - e. Deal Gulch #8-16 (API No. 05-081-07767)
- 3) Require the productive interval of the wellbore of any permitted wells to be located no closer than 600 feet from the unit boundaries.

APPLICABLE RULES AND ORDERS

- Rule 318.a. provides that a well drilled in excess of 2,500 feet in depth shall be located not less than 600 feet from any lease line, and shall be located not less than 1,200 feet from any other producible or drilling oil or gas well when drilling to the same source of

supply, unless authorized by order of the Commission upon hearing. The Application Lands are subject to this Rule for the Niobrara Formation.

One electronic (cogcc.hearings_unit@state.co.us), one original and two copies shall be filed with the Commission. **Anyone who files a protest or intervention must be able to participate in a prehearing conference during the week of February 22, 2016.** Pursuant to Rule 511., if the matter is uncontested, it may be approved without a hearing.
