On January 7, 2016, Bayswater Exploration & Production, LLC (Operator No. 10261) ("Bayswater" or "Applicant") filed a verified application pursuant to §34-60-116, C.R.S., for an order to:

- 1) Pool all interests in two approximate 320-acre wellbore spacing units ("WSU") established for the Application Lands, for the development and operation of the Niobrara Formation; and
