APPLICATION

On January 7, 2016, Great Western Operating Company, LLC (Operator No. 10110) ("Great Western" or "Applicant"), filed a verified application pursuant to §34-60-116, C.R.S. for an order to:

- 1) Subject additional parties to Order No. 407-1153 which pooled all interests within an approximate 320-acre wellbore spacing unit established for the Application Lands, for the development and operation of the Niobrara Formation.
- 2) Subject any non-consenting interests to the cost recovery provisions of §34-60-116(7), C.R.S., effective as of the earlier of the date of the Application, or the date that any of the costs specified in §34-60-116(7)(b), C.R.S. were first incurred for the drilling of the Schmunk EF 31-361HN Well (API No. 05-123-38932).

- On April 27, 1998, the Commission adopted Rule 318A, the Greater Wattenberg Area Special Well Location, Spacing and Unit Designation Rule.
- On October 27, 2014, the Commission entered Order No. 407-1153, which among other things, approves the request for an order to pool all interests in two approximate 160-acre designated horizontal wellbore spacing units, and all interests in two approximate 320-acre designated horizontal wellbore spacing units, for the development and operation of the Codell and Niobrara Formations.
- On July 20, 2015, the Commission entered Order No. 407-1400, which among other things, subjected additional parties to Order No. 407-1153, which pooled all interests in an approximate 320-acre wellbore spacing unit for the Application Lands, for the development and operation of the Niobrara Formation.
