APPLICATION

On January 7, 2016, Great Western Operating Company, LLC (Operator No. 10110) ("Great Western" or "Applicant"), filed a verified application pursuant to §34-60-116, C.R.S. for an order to:

- 1) Pool all interests in two approximate 160-acre designated wellbore spacing units established for the Application Lands, for the development and operation of the Codell and Niobrara Formations.
- 2) Subject any non-consenting interests to the cost recovery provisions of §34-60-116(7), C.R.S., effective as of the earlier of the date of the Application, or the date that any of the costs specified in §34-60-116(7)(b), C.R.S. were first incurred for the drilling of the Schmunk EF 31-362HN Well (API No. 05-123-38929) in WSU #1, and the Schmunk EF 31-363HC Well (API No. 05-123-38937) in WSU #2 (collectively the "Wells").
