On February 18, 2016 (amended March 8, 2016), PDC Energy, Inc. (Operator No. 69175) ("PDC" or "Applicant") filed a verified application pursuant to § 34-60-116 C.R.S. for an order to:

1) Pool all interests in nine approximate 320-acre horizontal wellbore spacing units established for the Application Lands, for the development and operation of the Niobrara and Codell Formations; and

2) Subject any nonconsenting interests to the cost recovery provisions of §34-60-116(7), C.R.S., effective as of the earlier of the date of the Application, or the drilling of the Spaur 10T-241 Well (API No. 05-123-42335), the Spaur 10T-301 Well (API No. 05-123-42336), the Spaur 10T-421 Well (API No. 05-123-42337), the Spaur 10T-201 Well (API No. 05-123-42322), the Spaur 10Q-241 Well (API No. 05-123-42323), the Spaur 10Q-321 Well (API No. 05-123-42332), the Spaur 10Q-401 Well (API No. 05-123-42326), the Spaur 10i-201 Well (API No. 05-123-42324), and the Spaur 10i-321 Well (API No. 05-123-42328).

- On April 27, 1998, the Commission adopted Rule 318A, the Greater Wattenberg Area Special Well Location, Spacing and Unit Designation Rule.
