APPLICATION

On February 18, 2016, Great Western Operating Company, LLC (Operator No. 10110) ("Great Western" or "Applicant"), filed a verified application pursuant to §34-60-116, C.R.S. for an order to:

- 1) Pool all interests in an approximate 320-acre drilling and spacing unit established for the Application Lands, for the development and operation of the Codell and Niobrara Formations.
- 2) Subject any non-consenting interests to the cost recovery provisions of §34-60-116(7), C.R.S., effective as of the earlier of the date of the Application, or the date that any of the costs specified in §34-60-116(7)(b), C.R.S. were first incurred for the drilling of the Cito Trust HC 01-039HC Well (API No. Pending), the Cito Trust HC 01-079HC (API No. Pending), the Cito Trust HC 01-119HN Well (API No. Pending), the Cito Trust HC 01-042HN Well (API No. Pending), the Cito Trust HC 01-082HN Well (API No. Pending), the Cito Trust HC 01-122HN Well (API No. Pending), the Cito Trust HC 01-079HN Well (API No. Pending), the Cito Trust HC 01-119HC Well (API No. Pending), and the Cito Trust HC 01-159HC Well (API No. Pending) (collectively, the "Wells").

- On April 27, 1998, the Commission adopted Rule 318A, the Greater Wattenberg Area Special Well Location, Spacing and Unit Designation Rule.
- On February 19, 1992 (amended August 20, 1993), the Commission entered Order No. 407-87 which, among other things, established 80-acre drilling and spacing units for the production of oil, gas, and associated hydrocarbons from the Codell-Niobrara formations, the Codell Formation, and the Niobrara Formation underlying certain lands, including the Application Lands, with the permitted well locations in accordance with the provisions of Order 407-1.
