APPLICATION

On May 19, 2016, GRMR Oil & Gas, LLC (Operator No. 10524) ("GRMR" or "Applicant") filed a verified application pursuant to Section 34-60-116, C.R.S., for an order to:

1) Establish one approximate 895.97-acre drilling and spacing unit for the Application Lands, for the production of oil, gas and associated hydrocarbons from the Niobrara Formation; and

2) Require the productive interval of the wellbore of any permitted wells to be located no closer than 400 feet from the unit boundaries, and no closer than 400 feet from the productive interval of any other wellbore located in the unit.

APPLICABLE RULES AND ORDERS

- Rule 318.a. provides that a well drilled in excess of 2,500 feet in depth shall be located not less than 600 feet from any lease line, and shall be located not less than 1,200 feet from any other producible or drilling oil or gas well when drilling to the same source of supply, unless authorized by order of the Commission upon hearing. The Application Lands are subject to this Rule for the Niobrara Formation.
