APPLICATION

On January 7, 2016, PDC Energy, Inc. (Operator No. 69175) ("PDC" or "Applicant"), filed a verified application pursuant to C.R.S. § 34-60-116 for an Order:

1) To apply the cost recovery provisions of C.R.S. § 34-60-116(7) to additional parties within an established 520-acre Wellbore Spacing Unit covering the Application Lands, established for Klein 19N-432 well (API #05-123-40150), which was pooled by Order No. 407-1669; and

2). For such other findings and orders as the Commission may deem proper or advisable in the premises.

- On April 27, 1998, the Commission adopted Rule 318A, the Greater Wattenberg Area Special Well Location, Spacing and Unit Designation Rule.
- On February 19, 1992, the Commission entered Order No. 407-87 (amended August 20, 1993) which, among other things, established 80-acre drilling and spacing units for the production of oil, gas, and associated hydrocarbons from the Codell-Niobrara formations, the Codell formation, and the Niobrara formation underlying certain lands, including the Application Lands, with the permitted well locations in accordance with the provisions of Order 407-1.
- On March 16, 2016, the Commission entered Order No. 407-1669 which, among other things, pooled all interests in the approximate 520-acre horizontal Wellbore Spacing Unit

established for the Application Lands, for the Klein 19N-432 well, for development and operation of the Codell formation.
