APPLICATION

On May 19, 2016, Extraction Oil & Gas LLC, Operator No. 10459, ("Extraction" or "Applicant") filed a verified application pursuant to §34-60-116, C.R.S., for an order to:

- 1) Vacate Order No. 407-1396, but only insofar as it relates to the Waag #19 Well;
- 2) Pool all interests in an approximate 400-acre designated horizontal wellbore spacing unit established for the Application Lands, for the development and operation of the Codell Formation; and
- 3) Subject any non-consenting interests to the cost recovery provisions of §34-60-116(7), C.R.S., effective as of the earlier of the date of the Application, or the date that any of the costs specified in §34-60-116(7)(b), C.R.S. were first incurred for the drilling of the Waag #19 Well (API No. 05-123-40351).

- On April 27, 1998, the Commission adopted Rule 318A, the Greater Wattenberg Area Special Well Location, Spacing and Unit Designation Rule.
- On or about July 20, 2015, the Commission entered Order No. 407-1396 which, among other things, pooled all interests in an approximate 320-acre horizontal wellbore spacing unit comprised of certain portions of the Application Lands for development and operation of the Codell Formation, and subjected any nonconsenting interests to the cost

recovery provisions of §34-60-116(7), C.R.S. for the drilling of the Waag #19 Well (API No. 05-123-40351).
