On August 19, 2016, Great Western Operating Company, LLC (Operator No. 10110) ("Great Western" or "Applicant"), filed a verified application pursuant to §34-60-116, C.R.S. for an order to:

- 1) Establish an approximate 1279.10-acre drilling and spacing unit for the Application Lands, for the production of oil, gas and associated hydrocarbons from the Codell and Niobrara Formations;
 - 2) Approve up to 21 horizontal wells within the unit; and
- 3) Require that the productive interval of any horizontal well be located no closer than 460 feet from the unit boundaries, and no closer than 150 feet from the productive interval of any other wellbore located in the unit, without exception granted by the Director.
- 4) Applicant requests that the proposed wells will be located on no more than one well pad within the drilling and spacing unit, unless an exception is granted by the Director.
