On August 25, 2016, Highlands Natural Resources Corporation, Operator No. 10625 ("Highlands" or "Applicant") filed a verified application pursuant to §34-60-116, C.R.S., for an order to:

- 1) Establish an approximate 1,280-acre drilling and spacing unit for Application Lands, and approve one horizontal well within the unit, for the production of oil, gas and associated hydrocarbons from the Niobrara Formation, and
- 2) Require the productive interval of the horizontal well to be no closer than 100 feet from the eastern and western boundaries of the DSU, no closer than 600 feet from the northern and southern boundaries of the DSU (regardless of the lease lines within the DSU), and no closer than 150 feet from the productive interval of another well producing from the same formation, unless an exception is granted by the Director.

 Rule 318.a. of the Rules and Regulations of the Oil and Gas Conservation Commission requires that, on unspaced lands, wells drilled in excess of 2,500 feet in depth be located not less than 600 feet from any lease line, and located not less than 1,200 feet from any other producible or drilling oil or gas well when drilling to the same common source of supply. Section 31 and 32, Township 5 South, Range 64 West, 6th P.M. are subject to this Rule for the Niobrara Formation.
