APPLICATION

On August 25, 2016, Extraction Oil & Gas LLC, Operator No. 10459, ("Extraction" or "Applicant") filed a verified application pursuant to §34-60-116, C.R.S., for an order to:

1) Pool all interests in four approximate 640-acre horizontal wellbore spacing unit, established for the Application Lands, for the development and operation of the Codell and Niobrara Formations; and

2) Subject any nonconsenting interests to the cost recovery provisions of §34-60-116(7), C.R.S., effective as of the earlier of the date of the Application, or the date that any of the costs specified in §34-60-116(7)(b), C.R.S., were first incurred for the drilling of the Varra #6 Well (API No. 05-123-39989) (WSU #1), the Varra #7 Well (API No. 05-123-39987) (WSU #2), the Varra #8 Well (API No. 05-123-39988) (WSU #3), and the Varra #9 Well (API No. 05-123-39986) (WSU #4).
