APPLICATION

On August 25, 2016, amended September 12, 2016, Synergy Resources Corporation, Operator No. 10311 ("Synergy" or "Applicant") filed a verified application pursuant to §34-60-116, C.R.S., for an order to:

1) Establish an approximate 480-acre drilling and spacing unit for Application Lands, and authorize the drilling of up to seven (7) horizontal wells within the unit, for the production of oil, gas and associated hydrocarbons from the Codell and Niobrara Formations, with the treated intervals of the wellbore of any permitted wells to be located not less than 75 feet from the east boundary of the unit, and not less than 460 feet from the north, south and west boundaries of the unit, with an inter-well setback of not less than 150 feet from the treated interval of a well producing from the Codell and Niobrara Formations, without exception being granted by the Director.

2) Applicant requests that the proposed wells will be located on no more than one well pad within the drilling and spacing unit, unless an exception is granted by the Director.
