On October 12, 2016, amended December 22, 2016, Whiting Oil and Gas Corporation (Operator No. 96155) ("Whiting" or "Applicant") filed a verified application pursuant to §34-60-116, C.R.S., for an order pooling all interests in an approximate 960-acre drilling and spacing unit established for the Application Lands for the development and operation of the Codell Formation and to subject any nonconsenting interests to the cost recovery provisions of Section 34-60-116(7), C.R.S., effective retroactive to the date of the Application or the date that the costs specified in Section 34-60-116(7), C.R.S., were first incurred, whichever is earlier, for the drilling of the Horsetail 30G-3143 Well (API No. 05-123-43039) for the development and operation of the Codell Formation on the Application Lands.

- On September 16, 2013, the Commission entered Order No. 535-413, which established six approximate 960-acre and two 640-acre drilling and spacing units and approved up to sixteen horizontal wells within each unit for the production of oil, gas and associated hydrocarbons from the Niobrara Formation. The Application Lands are subject to this Order.
- On July 28, 2014, the Commission entered Order No. 535-508, which modified Order No. 535-413, 535-413, 535-414, and 535-471 to include the Codell Formation in the established drilling and spacing units and approved up to thirty-two horizontal wells within each approximate 640 to 960-acre drilling and spacing units for the production of oil, gas and associated hydrocarbons from the Codell and Niobrara Formations. The Application Lands are subject to this Order.
