On October 13, 2016, Charles P. Dunning LLC (Operator No. 200077) ("Applicant") filed a verified application pursuant to § 34-60-116, C.R.S., for an order to:

1.) Establish an approximate 160-acre drilling and spacing unit upon the Application Lands with the well to be located no closer than 600 feet from the unit boundaries, without exception granted by the Director.

- Commission Rule 318.a. for unspaced lands provides that a well to be drilled in excess of two thousand five hundred (2,500) feet in depth shall be located not less than six hundred (600) feet from any lease line, and shall be located not less than one thousand two hundred (1,200) feet from any other producible or drilling oil or gas well when drilling to the same source of supply, unless authorized by order of the Commission upon hearing. The Application Lands are subject to this Rule for the Niobrara Formation.

One electronic (cogcc.hearings\_unit@state.co.us), one original and two copies shall be filed with the Commission. **Anyone who files a protest or intervention must be able to participate in a prehearing conference during the week of November 28, 2016.** Pursuant to Rule 511., if the matter is uncontested, it may be approved without a hearing.
