APPLICATION

On October 13, 2016, Noble Energy, Inc., Operator No. 100322 ("Noble" or "Applicant") filed a verified application pursuant to §34-60-116, C.R.S., for an order to:

1) Establish an approximate 1,600-acre drilling and spacing unit for the Application Lands; and

2) Authorize the drilling of two horizontal wells in the proposed unit, for production of oil, gas and associated hydrocarbons from the Codell and Niobrara Formations.

2) Applicant states that the treated intervals of the wellbore of any permitted wells will be located not less than 460 feet from outer boundaries of the unit, with an inter-well setback of not less than 150 feet from the treated interval of a well producing from the Codell and Niobrara Formations, unless an exception is granted by the Director.
