On October 13, 2016, Noble Energy, Inc., Operator No. 100322 ("Noble" or "Applicant") filed a verified application pursuant to §34-60-116, C.R.S., for an order to:

- 1) Establish an approximate 1,600-acre drilling and spacing unit for the Application Lands; and
- 2) Authorize the drilling of two horizontal wells in the proposed unit, for production of oil, gas and associated hydrocarbons from the Codell and Niobrara Formations.
- 2) Applicant states that the treated intervals of the wellbore of any permitted wells will be located not less than 460 feet from outer boundaries of the unit, with an inter-well setback of not less than 150 feet from the treated interval of a well producing from the Codell and Niobrara Formations, unless an exception is granted by the Director.
