On October 13, 2016, Verdad Oil & Gas Corporation, Operator No. 10485 ("Verdad" or "Applicant") filed a verified application pursuant to §34-60-116, C.R.S., for an order to:

Establish an approximate 1,282.12-acre drilling and spacing unit for Application Lands, and authorize the drilling of up to sixteen (16) horizontal wells within the unit, for the production of oil, gas and associated hydrocarbons from the Niobrara and Codell Formations, with the treated intervals of the wellbore of any permitted wells to be located not less than 460 feet from the unit boundaries with an interwell setback of not less than 150 feet from the treated interval of a well producing from the Niobrara and Codell Formations, without exception being granted by the Director.
