APPLICATION

On October 13, 2016, Kerr-McGee Oil & Gas Onshore LP (Operator No. 47120) ("Kerr-McGee" or "Applicant") filed a verified application pursuant to § 34-60-116 C.R.S. for an order to:

1) Pool all interests in one approximate 240-acre horizontal wellbore spacing unit and three approximate 480-acre horizontal wellbore spacing units established for the Application Lands, for the development and operation of the Niobrara and Codell Formations; and

2) Subject any nonconsenting interests to the cost recovery provisions of § 34-60-116(7), C.R.S. effective as of the earlier of the date of the Application, for the drilling of the Garfield 27C-14HZ well (API No. 05-123-42581), the Meese 1C-14HZ well (API No. 05-123-42537), the Meese 27N-14HZ well (API No. 05-123-42543), and the Meese 1N-14HZ well (API No. 05-123-42542).

- On April 27, 1998, the Commission adopted Rule 318A, the Greater Wattenberg Area Special Well Location, Spacing and Unit Designation Rule.
- On February 19, 1992 (amended August 20, 1993), the Commission entered Order No. 407-87 which established 80-acre drilling and spacing units for the production of oil, gas and associated hydrocarbons from the Niobrara Formation, with the permitted well locations in accordance with the provisions of Order No. 407-1.
