- 2) Subject any nonconsenting interests to the cost recovery provisions of § 34-60-116(7), C.R.S. effective as of the earlier of the date of the Application, for the drilling of the Garfield 37N-35HZ well (API No. 05-123-42575), the Meese 37C-35HZ well (API No. 05-123-42539), and the Meese 16N-35HZ well (API No. 05-123-42540).
