On October 13, 2016, Bison Oil & Gas, LLC (Operator No. 10618) ("Bison" or "Applicant") filed a verified application pursuant to §34-60-116, C.R.S., for an order pooling all interests in an approximate 960-acre drilling and spacing unit established for the development and operation of the Niobrara Formation and to subject any nonconsenting interests to the cost recovery provisions of Section 34-60-116(7), C.R.S., effective retroactive to the date of the Application or the date that the costs specified in Section 34-60-116(7), C.R.S., were first incurred, whichever is earlier, for the drilling of the Bison 4-64 15-16 1BHZ Well (API No. 05-005-07254), Bison 4-64 15-16 2BHZ Well (API No. 05-005-07255), and Bison 4-64 15-16 1CHZ Well (API No. 05-005-07256) for the development and operation of the Niobrara Formation on the Application Lands.

- On August 29, 2013, the Commission entered Order No. 535-738, which established an approximate 960-acre drilling and spacing unit and approved up to three horizontal wells within the unit for the production of oil, gas and associated hydrocarbons from the Niobrara Formation. The Application Lands are subject to this Order.
