On October 13, 2016, Kerr-McGee Oil & Gas Onshore LP, Operator No. 47120 ("Kerr-McGee" or "Applicant") filed a verified application pursuant to §34-60-116, C.R.S., for an order to:

1) Pool all interests in four approximate 400-acre horizontal wellbore spacing units, established for the Application Lands, for the development and operation of the Codell and Niobrara Formations; and

2) Subject any nonconsenting interests to the cost recovery provisions of §34-60-116(7), C.R.S., effective as of the earlier of the date of the Application, or the date that any of the costs specified in §34-60-116(7)(b), C.R.S., were first incurred for the drilling of the BBKB 37N-35HZ Well (API No. 05-123-43204) (WSU #1), the BBKB 37C-35HZ Well (API No. 05-123-43207) (WSU #2), the BBKB 16N-35HZ Well (API No. 05-123-43213) (WSU #3), and the BBKB 16N-A35HZ Well (API No. 05-123-43205) (WSU #4).
