On October 13, 2016, Bonanza Creek Energy Operating Co., LLC (Operator No. 9860) ("Bonanza Creek" or "Applicant") filed a verified application pursuant to §34-60-116, C.R.S., for an order to:

- 1) Approve an additional 15 horizontal wells, for a total of 20 wells, within the approximate 640-acre drilling and spacing unit established by Order No. 407-1126 for Section 18, Township 4 North, Range 62 West, 6th P.M., for the production of oil, gas and associated hydrocarbons from the Codell and Niobrara Formations, and
 - 2) Revert the setbacks from unit boundaries from 600 feet to 460 feet.
- 3) Applicant states that the proposed wells shall be drilled on the surface of the unit, subject to Rule 318.A.

- On April 27, 1998, the Commission adopted Rule 318A, the Greater Wattenberg Area Special Well Location, Spacing and Unit Designation Rule.
- On October 27, 2014, the Commission entered Order No. 407-1126 which, among other things, established an approximate 640-acre drilling and spacing unit for the Application Lands, and approved the drilling of up to five horizontal wells within the unit, for the production of oil, gas and associated hydrocarbons from the Codell and Niobrara Formations, with the productive interval of the wellbore located no closer than 600 feet from the unit boundaries, and an inter-well setback not less than 150 feet from the productive interval of any other Codell or Niobrara permitted or producing within the unit, without exception from the Director.
