APPLICATION

On November 9, 2016, Longs Peak Resources, LLC, Operator No. 10611 ("LPR" or "Applicant") filed a verified application pursuant to §34-60-116, C.R.S., for an order to:

- 1) Pool all interests in the approximate 1,366-acre drilling and spacing unit established for the Application Lands for the development and operation of the Codell Formation; and
- 2) Subject any nonconsenting interests to the cost recovery provisions of §34-60-116(7), C.R.S., effective as of the earlier of the date of the Application, or the date that any of the costs specified in §34-60-116(7)(b), C.R.S., were first incurred for the drilling of the MOTU East #28-21-16-1CH Well (API No. 05-123-40438).

- On September 15, 2014, the Commission entered Order No. 535-536 which, among other things, established an approximate 1,366-acre drilling and spacing unit for the Application Lands, and approved up to four horizontal wells within the unit, for the production of oil, gas and associated hydrocarbons from the Codell Formation, with the productive interval of the permitted wellbores to be located no closer than 300 feet from the unit boundaries, and no closer than 660 feet from the productive interval of any other wellbore located in the unit, unless an exception is granted by the Director.

NOTICE IS HEREBY GIVEN, pursuant to §§ 34-60-101 to -130, C.R.S. and the Commission's Rules of Practice and Procedure, 2 CCR 404-1, that the Commission has scheduled this matter for hearing on:


