- On April 19, 1990, the Commission issued Order No. 440-12 which, among other things, established 320-acre DSUs for certain lands, including Section 8, Township 7 South, Range 95 West, 6th P.M., for the production of gas and associated hydrocarbons from the Mesaverde Formation, with the designation as either E½ and W½ standup DSUs or N½ and S½ laydown DSUs at the discretion of the operator of the first well permitted, with the permitted well to be located on the established DSU no closer than 600 feet from the DSU boundaries and no closer than 1,200 feet from any well producing or producible from the same Mesaverde Formation.
- On February 22, 2010, the Commission entered Order No. 440-59 which, among other things, established an approximate 320-acre laydown DSU for the S½ of Section 8, Township 7 South, Range 95 West, 6th P.M., and approved the equivalent of one well per 10 acres well density, for the production of gas and associated hydrocarbons from the Williams Fork and Iles Formations.
