On December 1, 2016, Fifth Creek Energy Operating Company, LLC ("Fifth Creek" or "Applicant") filed a verified application pursuant to §34-60-116, C.R.S., for an order to:

- 1) Establish an approximate 1,280-acre drilling and spacing unit for Sections 21 and 28, Township 12 North, Range 62 West, 6th P.M. in DSU #1, and approve up to six new horizontal wells within the unit, for the production of oil, gas and associated hydrocarbons from the Codell Formation;
- 2) Establish an approximate 1,280-acre drilling and spacing unit for Sections 22 and 27, Township 12 North, Range 62 West, 6th P.M. in DSU #2, and approve up to six new horizontal wells within the unit, for the production of oil, gas and associated hydrocarbons from the Codell Formation:
- 3) Require that the productive interval any horizontal well in each of the proposed units be no closer than 300 feet from the boundaries of the unit and not less than 150 feet from the productive interval of another well within each unit,
- 4) Applicant states that the wells will be drilled from no more than a total of five well pads within each unit, unless an exception is granted by the Director.

 Rule 318.a. of the Commission Rules provides, on unspaced lands, a well to be drilled 2,500 feet or grater shall be located not less than 600 feet from any lease line, and shall be located not less than 1,200 feet from any other producible oil or gas well when drilling to the same common source of supply, unless authorized by the Commission.
