## <u>APPLICATION</u>

On December 5, 2016, Noble Energy, Inc., Operator No. 100322 ("Noble" or "Applicant") filed a verified application pursuant to §34-60-116, C.R.S., for an order to:

- 1) Establish an approximate 2,240-acre drilling and spacing unit for the Application Lands, for production of oil, gas and associated hydrocarbons from the Codell and Niobrara Formations; and
  - 2) Authorize the drilling of sixteen horizontal wells in the proposed unit.
- 3) Require that for any permitted well, the treated interval of the wellbore should be not less than 460 feet from the outer boundaries of the proposed unit, with an inter-well setback of not less than 150 feet from the treated interval of a well producing from the Codell and Niobrara Formations, unless the Director grants an exception.
- 4) Applicant states that any horizontal wells to be drilled in the unit will be drilled from no more than three multi-well pads on the surface of the drilling unit, or on adjacent lands with consent of the landowner, unless an exception is granted by the Director.

- On February 19, 1992, the Commission issued Order No. 407-87 (amended August 20, 1993), which among other things, established 80-acre drilling and spacing units for the production of oil and/or gas from the Codell and Niobrara Formations underlying certain lands, including the Application Lands, with the permitted well locations in accordance with the provisions of Order No. 407-1.
- On April 27, 1998, the Commission adopted Rule 318A, the Greater Wattenberg Area Special Well Location, Spacing and Unit Designation Rule.
