NOTICE OF HEARING

APPLICATION

On or before January 19, 2017, Great Western Operating Company, LLC ("Great Western" or "Applicant") filed a verified application pursuant to §34-60-116, C.R.S., for an order:

- 1) Allowing up to nineteen (19) wells in order to efficiently and economically recover the oil, gas and associated hydrocarbons from the Codell and Niobrara Formations in an approximate 640-acre drilling and spacing unit established by Order No. 407-833 for Section 11, Township 3 North, Range 68 West, 6th P.M.
- 2) Providing that the surface locations for the additional wells shall be located on no more than two pad locations within the unit or adjacent thereto, unless an exception is granted by the Director.
- 3) Providing that the treated interval of the wellbores shall be located no closer than 460 feet from the unit boundaries and no closer than 150 feet from the treated interval of any other wellbore located in the unit, without exception being granted by the Director.
- 4) For such other findings and orders as the Commission may deem proper or advisable in this matter.

- On February 19, 1992, the Commission entered Order No. 407-87 (amended August 20, 1993) which, among other things, established 80-acre drilling and spacing units for the production of oil, gas and associated hydrocarbons from the Codell and Niobrara Formations, with permitted well locations in accordance with the provisions of Order No. 407-1.

- On August 27, 2013, effective as of July 29, 2013, the Commission entered Order No. 407-833 which, among other things, established an approximate 640-acre horizontal drilling and spacing unit for the Application Lands, and approved up to twelve (12) horizontal wells within the drilling and spacing unit for the production of oil, gas and associated hydrocarbons from the Codell-Niobrara Formation, with the treated interval of the wellbore to be located no closer than 460 feet from the unit boundaries and no closer than 150 feet from the treated interval of any other wellbore located in the unit, without exception being granted by the Director, and providing that Applicant may use its existing surface blanket bond to locate the wellpads for the proposed horizontal wells at a surface location outside the applicable GWA drilling window within the unit.

One electronic (cogcc.hearings_unit@state.co.us), one original and two copies shall be filed with the Commission. **Anyone who files a protest or intervention must be able to participate in a prehearing conference during the week of March 6, 2017.** Pursuant to Rule 511, if the matter is uncontested, it may be approved without a hearing.
