On January 19, 2017, Noble Energy, Inc., Operator No. 100322 ("Noble" or "Applicant") filed a verified application pursuant to §34-60-116, C.R.S., for an order to:

- 1) Establish an approximate 1,900.4-acre drilling and spacing unit for the Application Lands; and
- 2) Authorize the drilling of 17 horizontal wells in the proposed unit, for production of oil, gas and associated hydrocarbons from the Codell and Niobrara Formations.
- 3) Applicant states that the treated intervals of the wellbore of any permitted wells will be located not less than 460 feet from outer boundaries of the unit, with an inter-well setback of not less than 150 feet from the treated interval of a well producing from the Codell and Niobrara Formations, unless an exception is granted by the Director.
- 4) Applicant states that any horizontal wells to be drilled under this Application will be drilled from three multi-well pads on the surface of the drilling unit, or on adjacent lands with consent of the landowner, unless an exception is granted by the Director.
