On January 19, 2017, Crestone Peak Resources Operating, LLC, Operator No. 10633 ("Crestone" or "Applicant") filed a verified application pursuant to §34-60-116, C.R.S., for an order to:

- 1) Pool all interests in two approximate 320-acre horizontal wellbore spacing units and two approximate 160-acre horizontal wellbore spacing units, established for the Application Lands, for the development and operation of the Niobrara and Codell Formations; and
- 2) Subject any nonconsenting interests to the cost recovery provisions of §34-60-116(7), C.R.S., effective as of the earlier of the date of the Application, or the date that any of the costs specified in §34-60-116(7)(b), C.R.S., were first incurred for the drilling of the Hwy 52 4L-32H-O268 Well (API No. 05-123-38244) (WSU No. 1), the Hwy 52 4M-32H-O268 Well (API No. 05-123-38250) (WSU No. 2), the Hwy 52 4N-32H-O268 Well (API No. 05-123-38251) (WSU No. 3) and the Hwy 52 4O-32H-O268 Well (API No. 05-123-38254) (WSU No. 4).
