APPLICATION

On January 19, 2017, Enerplus Resources (USA) Corporation, Operator No. 10177 ("Enerplus" or "Applicant") filed a verified application pursuant to §34-60-116, C.R.S., for an order to:

- 1) Establish an approximate 1,280-acre drilling and spacing unit for the Application Lands, for production of oil, gas and associated hydrocarbons from the Fort Hayes, Carlile, Codell and Niobrara Formations; and
- 2) Authorize the drilling of eight horizontal wells in the proposed unit, with the treated intervals of the wellbore to be located not less than 600 feet from the outer boundaries of the proposed unit, with an inter-well setback of not less than 150 feet from the treated interval of a well producing from the Fort Hayes, Carlile, Codell and Niobrara Formations, unless an exception is granted by the Director.
- 3) Applicant states that any horizontal wells to be drilled in the unit will be drilled from no more than two multi-well pads on the surface of the drilling unit, or on adjacent lands with consent of the landowner, unless an exception is granted by the Director.

- Rule 318.a. of the Commission Rules provides a well to be drilled 2,500 feet or greater shall be located not less than 600 feet from any lease line, and shall be located not less

than 1,200 feet from any other producible oil or gas well when drilling to the same common source of supply, unless authorized by the Commission upon hearing.

One electronic (cogcc.hearings_unit@state.co.us), one original and two copies shall be filed with the Commission. **Anyone who files a protest or intervention must be able to participate in a prehearing conference during the week of March 6, 2017.** Pursuant to Rule 511., if the matter is uncontested, it may be approved without a hearing.
