APPLICATION

On or before January 19, 2017, Great Western Operating Company, LLC (Operator No. 10110) ("Great Western" or "Applicant"), filed a verified application pursuant to §34-60-116, C.R.S., for an order to:

1) Pool all interests in seven approximate 640-acre designated horizontal wellbore spacing units established for the Application Lands, for the development and operation of the Niobrara and Codell Formations; and

2) Subject any non-consenting interests to the cost recovery provisions of §34-60-116(7), C.R.S., effective as of the earlier of the date of the Application, or the date that any of the costs specified in §34-60-116(7)(b), C.R.S., are first incurred for the drilling of the Schneider HD 11-222HC (API No. 05-123-41742) (WSU #1), Schneider HD 11-259HN (API No. 05-123-41741) (WSU #2), Schneider HD 11-262HN (API No. 05-123-41750) (WSU #3), Schneider HD 11-262HC (API No. 05-123-41743) (WSU #4), Schneider HD 11-299HN (API No. 05-123-41745) (WSU #5), Schneider HD 11-339HC (API No. 05-123-41751) (WSU #6) and the Schneider HD 11-339HN (API No. 05-123-41749) (WSU #7) ("Wells").

- On April 27, 1998, the Commission adopted Rule 318A, the Greater Wattenberg Area Special Well Location, Spacing and Unit Designation Rule.
- On February 19, 1992 (amended August 20, 1993), the Commission entered Order No. 407-87 which, among other things, established 80-acre drilling and spacing units, for the production of oil, gas, and associated hydrocarbons from the Codell-Niobrara Formations, the Codell Formation, and the Niobrara Formation underlying certain lands,

including the Application Lands, with the permitted well locations in accordance with the provisions of Order No. 407-1.
