APPLICATION

On January 19, 2017, Extraction Oil & Gas LLC (Operator No. 10459) ("Extraction" or "Applicant") submitted a request for hearing pursuant to Rule 318A.e.(5) requesting a hearing on an objection to thirty-three proposed horizontal wellbore spacing units made by Noble Energy, Inc. Extraction requests an order to:

1) Establish seven approximate 160-acre and twenty-six approximate 320-acre horizontal wellbore spacing units pursuant to Rule 318A for the Application Lands, wherein Extraction plans to drill horizontal wells, the Telep North, Telep South, and Bindi wells, for the production of oil, gas and associated hydrocarbons from the Codell-Niobrara Formation. Noble Energy, Inc. submitted an objection to the formation of said wellbore spacing units.

- On April 27, 1988, the Commission adopted Rule 318A which, among other things, allowed certain drilling locations to be utilized to drill or twin a well, deepen a well or recomplete a well and to commingle any or all Cretaceous Age Formations from the base of the Dakota Formation to the surface. Rule 318A supersedes all prior Commission drilling and spacing orders affecting well location and density requirements of Greater Wattenberg Area wells. On December 5, 2005, Rule 318A was amended, among other things, to allow interior infill and boundary wells to be drilled and wellbore spacing units to be established. On August 8, 2011, Rule 318A was again amended, among other things, to address drilling of horizontal wells. The Application Lands are subject to Rule 318A for the Codell and Niobrara Formations.
- Rule 318A.e.(5)C. provides that if an objection to a proposed Rule 318A.a.(4)
 horizontal wellbore spacing unit is received, the operator proposing a wellbore
 spacing unit may seek a hearing before the Commission on the objection and
 creation of the unit.
