APPLICATION

On March 2, 2017, Highlands Natural Resources Corporation, Operator No. 10625 ("Highlands" or "Applicant") filed a verified application pursuant to §34-60-116, C.R.S., for an order to:

1. Approve an additional 15 horizontal wells, for a total of 16 horizontal wells within an approximate 1280-acre drilling and spacing unit requested in Docket No. 161000415 for the Application Lands, for production of oil, gas and associated hydrocarbons from the Niobrara Formation, with a wellbore orientation in a general east/west direction and the setbacks to be the same as requested in Docket No. 161000415.

- On August 25, 2016, Applicant filed an application in Docket No. 161000415 to establish an approximate 1,280-acre exploratory drilling and spacing unit for Sections 31 and 32, Township 5 South, Range 64 West, 6th P.M., and approve one horizontal well within the proposed unit, for the production of oil, gas and associated hydrocarbons from the Niobrara Formation, with the productive interval of the horizontal well to be no closer than 100 feet from the eastern and western boundaries of the unit, no closer than 600 feet from the northern and southern boundaries of the unit (regardless of the lease lines within the unit), and no closer than 150 feet from the productive interval of another well producing from the same formation, unless an exception is granted by the Director. The authorized wells will be in a general east-west orientation.
