APPLICATION

On March 2, 2017, Great Western Operating Company, LLC (Operator No. 10110) ("Great Western" or "Applicant"), filed a verified application pursuant to §34-60-116, C.R.S., for an order to:

1) Pool all interests in seven approximate 640-acre designated horizontal wellbore spacing units established for the Application Lands, for the development and operation of the Niobrara and Codell Formations; and

2) Subject any non-consenting interests to the cost recovery provisions of §34-60-116(7), C.R.S., effective as of the earlier of the date of the Application, or the date that any of the costs specified in §34-60-116(7)(b), C.R.S., are first incurred for the drilling of the Marcus LD 11-363HN (API No. 05-123-43992) (WSU #1), the Marcus LD 11-364HN (API No. 05-123-43994) (WSU #2), the Marcus LD 11-365HC (API No. 05-123-43993) (WSU #3), the Marcus LD 11-365HN (API No. 05-123-43995) (WSU #4), the Marcus LD 11-367HN (API No. 05-123-44037) (WSU #5), the Marcus LD 11-367HC (API No. 05-123-44038) (WSU #6), and the Marcus LD 11-368HN (API No. 05-123-44036) (WSU #7).

- On April 27, 1998, the Commission adopted Rule 318A, the Greater Wattenberg Area Special Well Location, Spacing and Unit Designation Rule.
- On February 19, 1992 (amended August 20, 1993), the Commission entered Order No. 407-87 which, among other things, established 80-acre drilling and spacing units, for the production of oil, gas, and associated hydrocarbons from the Codell-Niobrara Formations, the Codell Formation, and the Niobrara Formation underlying certain lands,

including the Application Lands, with the permitted well locations in accordance with the provisions of Order No. 407-1.
