On March 2, 2017 (Amended March 24, 2017), Bison Oil & Gas, LLC (Operator No. 10618) ("Bison" or "Applicant"), filed a verified application pursuant to § 34-60-116, C.R.S., for an order to:

- 1) Approve an additional 14 horizontal wells for a total of 16 horizontal wells within an approximate 1,280-acre drilling and spacing unit established for the Application Lands by Order No. 535-661, for the production of oil, gas and associated hydrocarbons from the Niobrara Formation; and
- 2) Require the productive interval of the wellbore of any permitted wells within the unit to be located no closer than 460 feet from the unit boundaries, and no closer than 150 feet from the productive interval of any other wellbore located in the unit, unless an exception is granted by the Director.
- 3) Applicant states that the wells shall be drilled from no more than three wellpads within the unit, or from a legal location on adjacent lands.

On April 13, 2015, the Commission entered Order No. 535-661, which established an approximate 1,280-acre drilling and spacing unit covering Sections 27 and 28, Township 4 South, Range 64 West, 6th P.M. and approved up to two horizontal wells within the unit for the production of oil, gas and associated hydrocarbons from the Niobrara Formation with the treated interval of the wellbores to be located no closer than 960 feet from the treated interval of any other wellbore producing from the Niobrara Formation, and no closer than 460 feet from the unit boundary, without exception being granted by the Director.
